



## Review of Representation Arrangements

Under sections 19H and 19J of the Local Electoral Act 2001, the Ōpōtiki District Council is required to carry out a review of its representation arrangements for the triennial local authority elections to be held in 2022.

### Statement of Proposal

At the Council meeting on 30 August 2021 for the representation arrangements review, Council resolved as its initial proposal that there be:

- (a) 6 councillors, plus the mayor (being the status quo);
- (b) 3 wards, being the:
  - **Coast Ward** (1 councillor), comprising the area in SO Plan 8392 (being the status quo);
  - **Ōpōtiki Ward** (3 councillors), comprising the area in SO Plan 334312 (being the status quo);
  - **Waioeke-Waiōtahe-Otara Ward** (2 councillors), comprising the area in SO Plan 334314 (being the status quo).
- (c) 1 community board, being:
  - **Coast Community Board** (4 members, plus 1 appointed councillor representing the Coast Ward), comprising the area of SO Plan 8392 (being the status quo);

The 3 wards, the number of councillors per ward, the ward populations (estimated as at 30 June 2020) and the population ratio per councillor are as follows:

Ward	No. Councillors	Population	Population Ratio	% Variation
Coast	1	1,510	1,510	-9.6%
Ōpōtiki	3	5,230	1,743	+4.37%
Waioeke-Waiōtahe-Otara	2	3,280	1,640	+1.8%

In accordance with section 19V(2) of the Local Electoral Act 2001, the population that each councillor represents must be within the population range of 1,670 plus or minus 10% (1,503 - 1,837).
