

Sport NZ Rural Travel Fund

The Sport NZ Rural Travel Fund is a partnership between Sport NZ and territorial authorities to assist the development of junior sport in rural communities by providing a travel subsidy.

Application for the rural travel fund is open to rural sports clubs and rural school teams with young people aged between 5 and 18 years who require subsidies to assist with transport expenses to local sporting competitions.

Funding cannot be provided for the purpose of travel to regional or national events and funding cannot be provided for individuals. Funding is for regular local competition e.g. Saturday morning or week night games.

The following criteria shall be applied when considering applications for funding. School club teams and sport club teams are defined as:

"a school club team participating in regular local sport competition out of school time, that excludes inter school and intra school competitions played during school time"

and/or;

"a sports club team participating in organised, regular sport competition through club membership outside of school time"

Sport NZ requires organisations that receive funding to return an accountability form showing proof of purchases made within the funding period and attach any receipts.
